HONORABLE MICHELLE RICK, 29TH CIRCUIT COURT, CLINTON AND GRATIOT COUNTIES

In 2007, Governor Jennifer M. Granholm appointed the Honorable Michelle Rick to the 29th Circuit Court. Prior to that, and following a brief time in private practice, Judge Rick worked as a public employee, first as an assistant prosecutor in Livingston County, followed by service to the State of Michigan as an assistant attorney general and deputy legal counsel to Governor Granholm. Judge Rick hears family, criminal, and civil cases for the 29th Circuit Courts (Clinton and Gratiot counties).

Judge Rick is a proud graduate of Michigan State University and the University of Detroit Mercy School of Law, cum laude, and is a member of the Justice Frank Murphy Honor Society. Judge Rick is the District 7 Director for the National Association of Women Judges for Michigan, Ohio, and West Virginia. Judge Rick is a member of the Executive Committee for the Michigan Judges Association, where she Co-Chairs the Outreach and Planning Committee. In 2015, Judge Rick was appointed by Governor Snyder to the Human Trafficking Commission.

She is an active member of the Clinton and Gratiot County Community Corrections boards, and is on the Board of Directors for SafeCenter. Judge Rick has presented at ICLE's Family Law Institute and the 2010 Judicial Conference, and has served as faculty for the National Judicial Institute on Domestic Violence. Judge Rick currently teaches Access to Justice at UDM Law, and has previously served as an adjunct law professor at MSU Law and Cooley Law schools.
