This session will address the benefits and challenges in advancing women in lead roles in complex litigation. Lief Cabraser partner Sarah London is a true leader in the plaintiffs’ bar and a determined, skilled, and experienced advocate for the injured, employees, and consumers. Sarah also serves in lead roles in multiple women’s health cases, including as Liaison Counsel in the state court coordinated proceedings involving the destruction of hundreds of frozen eggs and embryos at San Francisco’s Pacific Fertility Center.
