

March 5, 2024 Report of the Annual Conference Site Selection Committee Chair: Honorable Marcella A Holland

Our committee met on January 22,2024. Prior to the meeting, a revised Request for Proposal (RFP) for hosting the Annual Conferences in 2026 and 2027 was circulated to the committee. This is the first year we are seeking to recommend a conference site for two consecutive years. We believe that some venues may need more than the less than 2 years once the Board votes, to actually prepare to host an annual conference, especially with fundraising. Therefore, our goal is to lengthen the time that a jurisdiction will have to finalize plans for hosting an annual conference to less than 3 years, starting with 2027. This change also helps staff to negotiate earlier for a better hotel rate in the chosen jurisdiction.

During our meeting a few minor changes were made to the RFP and it was approved to be circulated to District Directors and state chairs and to be posted on our website for all members to review. We also requested that the RFP be included as part of a notice or monthly update email. The deadline set for receipt of Proposals is April 15, 2024. The Committee will meet shortly thereafter to make a decision on the sites. If we do not receive any or only 1 proposal, we will assess other options of securing a second proposal for the other year or proposals for both years. We do not anticipate receiving no proposals this year since we are now free to go to any jurisdiction that complies with our anti-discrimination policy confirmed with an affirmation by the applicant member.

The Committee will present its recommendations to the Executive Committee at its August meeting and if accepted, at the outgoing Board meeting in October in San Diego.

February ~ 5 Minute Ensuring Racial Equity Corner: Words (and their Historical Roots) Matter

As we celebrate Black History Month, we invite NAWJ members to take a moment to reflect on the tremendous contributions of Black people in our nation's history. We further encourage you to think about common words or phrases that may have their roots in racial oppression. For example, when you hear the term "grandfathered in" or "grandfather clause," what do you think of? Did you know that the term originates from laws and constitutional amendments passed by Southern states during Reconstruction that effectively prevented Black citizens from voting? In brief, those laws and constitutions only allowed men whose fathers or grandfathers had the right to vote as of a certain, earlier date (e.g., before the Civil War) the ability to register to vote. Those restrictions, along with other requirements like poll taxes or literacy tests, made it nearly impossible for Black men to vote. Therefore, while some may consider it to be "just a word," the term "grandfathered" derives from a harmful, legal framework that disenfranchised scores of formerly enslaved persons following the Civil War. Instead of using the term, consider using "exempted." The Supreme Court has referred to grandfather clauses as one of "a variety of notorious methods" used by states to suppress the rights of Black voters after the 15th Amendment was ratified. Brnovich v. Democratic Nat'l Comm., 594 U.S. ---, 141 S. Ct. 2321, 2330 (2021). For another example of a judicial opinion noting this history see Comstock v. Zoning Bd. of Appeals of Gloucester, 98 Mass. App. Ct. 168 n. 11 (2020). Moreover, take a moment to consider our nation's history and how that impacts terms and phrases that many deem innocuous.

The Diversity & Inclusion Committee's new co-chairs began their work in January 2024.

On January 17, 2024, the D&I Committee hosted a webinar, "Why D&I Plan Matters" for the membership body. The webinar began with Director Rachel Rossi of the Department of Justice's Office for Access to Justice, discussing diversity and inclusion its need and implementation. Judge Applewhite took the membership through NAWJ's Diversity and Inclusion Plan ("Plan") adopted by the Board in 2021. The Plan set forth details on the following:

Midyear Report, of the Immigration Committee Honorable Joan Churchill, Chair March 14, 2024

Membership

Membership on the NAWJ Immigration Committee, chaired by Retired Immigration Judge Joan Churchill and Retired Immigration Judge Carol King, Vice Chair, includes active and retired Immigration Judges, the current and immediate past President of NAIJ [the National Association of Immigration Judges], state court judges who have handled immigration cases as lawyers or judges and a retired judge who handles immigration cases pro bono for members of the U.S. military and has been mentoring and helping Afghan women judges who migrated to the United States after the fall of the Taliban.

Meetings

The Committee has met twice since the preparation of our 2023 Annual report. We met in person at the 2023 Annual jointly with the Retired/Senior Judges Committee which is also chaired yours truly. We met by zoom video conference call on December 7. Our next meeting is scheduled for March 21, 2024, by zoom.

WEBINARS

1. ABA JD NCALJ webinar on Article I courts.

The Committee has agreed to cosponsor a webinar on April 17, 2024, about Article I courts, which is being organized by the National Conference of Administrative Judges, [NCALJ] a conference of the Judicial Division of the American Bar Association [ABA]. The webinar is designed to present Article I courts as a possible model for administrative tribunals in general. The webinar will draw heavily from the extensive advocacy in recent years for restructuring of the Immigration Courts as Article I courts. Speakers will include

- Karen Grisez, a pro bono immigration attorney who chaired the ABA Immigration Commission and spear headed the issuance of two reports which called for establishment of Article I Immigration Courts,
- Betty Stevens, a retired immigration attorney with the Office of Immigration
 Litigation in the U.S. Department of Justice [DOJ], who was involved with drafting a
 bill on behalf of the Federal Bar Association [FBA] to create an Article I Immigration
 court.
- Jeremy Grayboyes, Research Director for the Administrative Conference of the United States [ACUS], who has written extensively about administrative tribunals.

Immigration Judge Mimi Tsankov, has taken the lead in connection with this webinar. Judge Tsankov, a past cochair of this Committee, is President of the National

Association of Immigration Judges [NAIJ] and currently Chair Elect of NCALJ, Uncertainty has arisen about whether Judge Tsankov will be able to moderate the panel, as the DOJ, in which the Immigration Courts are housed, recently began requiring NAIJ officers to obtain advance approval for speaking engagements. Judge Tsankov's request for approval to participate in the panel is pending. In light of this development, Judge Churchill has agreed to join the panel as back up moderator.

2. Child labor by Migrant Children

The Committee agreed to develop a webinar on the phenomenon of child labor by recent migrant children, largely unaccompanied, who are in the United States to pursue asylum applications. This topic has been the subject of an expose by the New York Times, and has attracted attention by other media. We are in the early stages of developing this webinar. The NAWJ Human Trafficking Committee has agreed to joint sponsorship, as has the NAWJ Juvenile Justice Committee.

3. Special Immigrant Juvenile Status

Judge Tiffany Palmer of this committee, who organized our excellent webinar of this subject last year, emphasizing the role of state court judges, wrote up a comprehensive summary of the webinar in light of the fact that it was not recorded. NAIJ

Our Committee continues to follow the status of the National Association of Immigration Judges, which was decertified as a bargaining unit by a decision of the Federal Labor Relations Authority about 50 years after the status was first accorded. There has been no progress to date in gaining recertification. As mentioned above, the Executive Office for Immigration Review, housed in the Department of Justice, has recently, citing NAWJ's loss of status as a collective bargaining unit, begun requiring NAIJ officers to obtain advance approval for speaking engagements, as well as written publications.

AFGHAN WOMEN JUDGES

Our Committee members continue to provide assistance to the Afghan Women judges located in the U.S. who fled the Taliban takeover of Afghanistan. Member Beverly Cutler has been particularly active in leading a team of NAWJ volunteers in the DC/MD/VA area. She wrote an inspiring article for CounterBalance, describing the many ways in which she has been providing assistance to Afghan women judges in the DC/MD/VA area who fled Afghanistan after the takeover by the Taliban. Report of the NAWJ Membership Outreach and Retention Committee for the 2024 Midyear Conference Board Meeting

Summary:

We apologize that the NAWJ Membership Outreach and Retention Committee, a small committee, has not accomplished much since the October Annual Meeting—because only one committee member besides the co-chairs has shown interest in participating in the committee. Please see Appendix A where we detail the steps taken. We have beseeched the national office and President Sage to appoint more members. Recently President Sage included a message in the February Monthly Update inviting interest in the committee. This monthly update was distributed electronically to all NAWJ members. The apparent lack of response is disappointing, because our mission is to encourage women judges to join NAWJ, and to help engage existing NAWJ members to make them feel involved and connected to NAWJ.

Membership:

Our current committee includes only state judicial officers, albeit in a variety of types and levels of courts. We co-chairs believe the committee should be more inclusive to strengthen membership. Our committee has no federal judges or military judges, nor any NAWJ Past Presidents or current Board members. We encourage the Board or President to appoint a more robust group to better represent NAWJ's geographically broad, and personally and professionally diverse, membership.

Meetings:

Since the Annual Conference, the committee has not met due to lack of interest, although in the previous two years, we tried to meet about every six weeks. The new co-chair, Judge Dawn Rogers, has met several times with continuing co-chair, Bev Cutler, learning of all the committee's past work, reviewing previous meeting agendas and reports, and strategizing about how to get the committee going. There has been significant and lasting non-response to Judge Rogers' emails inviting participation. Like many NAWJ committees with members located all across the country, the challenge of finding a time to meet may be part of the problem.

Plan of Action:

Co-chairs will follow up, individually, with each committee member for confirmation they truly don't want to be members. Perhaps there is issue with emails. If no new members, we will proceed with whoever attends meetings (once we agree on monthly date/time.)

Membership

Our membership spans the USA, with members from Florida to Alaska, from East Coast to West Coast, and from many states in the heartland. We are a large committee, with over 30 members.
