Congratulations to Juvenile Court **Judge Gloria Tan**. Judge Tan and her team at the Cambridge Juvenile Court received a Trial Court Innovation Grant and used the funds to install artwork created by the Department of Youth Services and court-involved youth as well as students from the Community Charter School of Cambridge. Judge Tan also used the funds to set up a trauma-informed, family-friendly area in the courthouse where young children can sit, read, play games, color, and the like.
