Alameda County Superior Court Judge Noel Wise has been nominated to fill a vacancy in the United States District Court for the Northern District of California. The U.S. Senate Judiciary Committee approved her nomination on August 1, 2024, and she awaits the full Senate's consideration.

This has been a momentous year for NAWJ member Judge Wise, who received the California Women Lawyer's 2024 Rose Bird Award. Since 2000, this award has honored judges from the northern portion of California based upon excellence as a jurist, longstanding and/or groundbreaking public service, and service as an inspiration to women lawyers in California.

San Diego County District Attorney Summer Stephan was honored with the prestigious Attorney General's Award for Meritorious Public Service. This is the highest public service award from the U.S. Department of Justice, which recognizes the most significant contributions of citizens and organizations in advancing justice. DA Stephan was honored for her extraordinary leadership, unwavering commitment to justice, and innovative approaches to enhance public safety. DA Stephan serves as Co-Chair of NAWJ's Human Trafficking Committee, and President-Elect of the National District Attorney's Association.
