Cross-Systems Mapping to Support Healthy Families


**Upstream Massachusetts** is a child welfare mapping initiative led by the Juvenile Court Department and developed in collaboration with the National Center for State Courts. The project is designed to help communities work across systems to strengthen families and support safe, nurturing, and permanent homes for children.

**Upstream** brings local stakeholders together for a series of action-oriented working meetings using a tool informed by the *Sequential intercept Model*.\* Stakeholders engage in a facilitated process to collectively map the local child welfare landscape, identify resources and gaps in services, agree on priorities, and create an action plan to enhance collaboration within and across systems. **Vision** 

- Strong families
- Safe, stable, and nurturing homes
- Community-based, coordinated, and comprehensive prevention and intervention networks

#### Mission

- Support data-driven, evidence-based, and culturally appropriate practices
- Facilitate and enhance collaboration and coordination among partners and across systems
- Reduce the risk of child maltreatment, family disruption, and trauma




# UPSTREAM AT THE LOCAL LEVEL

**Key Components** 

## PLANNING

- Assemble cross-systems county-level planning group
- Inventory local resources and key stakeholders
- Facilitate focus groups and key informant interviews across systems
  - Child welfare, courts, schools, law enforcement, attorneys and advocates, healthcare, youth and family services, social services, behavioral health treatment and recovery support providers
- Begin data collection and disseminate community selfassessment
- Identify gaps and organize along child welfare landscape


- Review data and risk and protective factors Review and refine gap analysis according to child welfare landscape
