# REPORT OF NAWJ PRESIDENT Joan Churchill For the 2013 Midyear Board Meeting

#### Prepared April 24, 2013

The first half of my term has been chock full for NAWJ and for your President. One of my first responsibilities was to appoint the Committee Chairs and members of the Committees. They are all now in place. Our Districts and Committees are humming with activity. The number of programs –and they are top-notch programs -- being planned around the country is higher than ever. We have a new exciting project underway to educate voters on Judicial Elections. We have taken positions on pending legislative matters: from judicial appointments and reauthorization of the Violence Against Women Act, at the Federal level, to a Maryland bill calling for restrictions on the shackling of pregnant inmates. Copies of our position statements are in the Appendix. We have prepared a proposal offering to host the 2016 IAWI Biennial, which is awaiting consideration by the IAWI Board of Directors. We are engaged in collaborative relationships with multiple organizations. NAWJ representatives have attended or are committed to attend meetings of numerous On the membership front, we have enthusiastic efforts partner organizations. underway to attract more male judges and more Tribal judges. Your President is engaged in an ambitious schedule of travel in order to attend events throughout the Districts, in different parts of the country. We have distributed and are working on a variety of publications including monthly email updates, Counterbalance, the 2013 Membership Directory, and an updated Board Member Manual.

We gather to meet in beautiful Washington DC for what promises to be a spectacular Midyear Leadership Conference. Registration for the Midyear, which is open to all our members, has been so high that we find we are at capacity for our events.

It is an honor, a privilege and a pleasure to serve as President of an organization with such a high level of enthusiasm by the members. The involvement of all of you on the Board has been fantastic. Thank you for your support of the organization. We all owe tremendous thanks to our incredibly dedicated staff, Executive Director Marie Komisar, Director of Finance and Administration Craig Evans, Senior Program and Publications Manager Lavinia Cousin, and Conference Manager Mary-Kathleen Todd. I had the good fortune to take the helm of NAWJ following the outstanding year of our Immediate Past President, Judge Amy Nechtem, who left NAWJ in a strong position. Building on that strength, we have gone forward to adopt numerous new initiatives.

#### New Initiatives

#### 1. New Projects

- **a.** Particularly exciting is the new project recently approved by the Board, the Judicial Elections-Smart Voter, referenced above. Drafted by our member Judge Joan Irion, it is designed to educate voters in states which elect judges, about the role of a judge and the relevant criteria for selection of a fair, impartial and independent state judiciary.
- **b.** A data base of members here and judges in other countries willing to participate in judicial exchanges/visits is being prepared by the Projects Committee, under the leadership of Judge Sue Yang, who also chairs a new Subcommittee of the International Outreach Committee on International Exchanges & Visits.

#### 2. Committees

**a.** To assure that the committees are running smoothly and to provide a liaison to keep abreast of what they are doing, we created a new position of Committee Chairs Coordinator. Judge Sandra Robinson is graciously filling that role. She has scheduled a meeting of the Committee Chairs during the Midyear.

#### **b.** New Committees created are:

- the 2016 IAWJ Biennial Proposal Special Committee, chaired by Judge Jane Craney, which prepared a proposal for hosting the 2016 IAWJ Biennial in Washington DC. The proposal was approved by the NAWJ Executive Committee and submitted to the IAWJ Board of Directors in February.
- four subcommittees of the International Outreach Committee: a subcommittee on International Courts chaired by Col. Linda Murnane, a Subcommittee on Judicial Exchanges and Visits chaired by Judge Sue Yang, a Subcommittee on Mexican Judges chaired by Judge Maritza Segarra, and a Subcomittee on Scholarships for NAWJ Conferences, chaired by Judge Judith Chirlin.
- a committee on Judicial Elections, to conduct the work of our new Judicial Elections-Smart Voter project, chaired by Judge Joan Irion, its creator.
- a subcommittee for Data Review for the Membership Committee, chaired by Patricia Hurst,
- a Personnel Committee to review staff pay, benefits, duties and performance, chaired by Judge Julie Frantz, NAWJ Secretary, as required by the Bylaws
- a Website Improvement Special Task Force, chaired by Judge Sheri Roman, to execute the report she prepared as Projects Chair last year analyzing changes needed to the NAWJ website.
- The Policies Review Subcommittee of the Executive Committee, chaired by Judge Amy Nechtem.
- **c.** We created a Council of Past Presidents, chaired by our founder Judge Joan Dempsey Klein, to provide current leadership with the benefit and wisdom of our past Presidents.

- **d.** We expanded the scope of the Awards Committee to consider nominating members on occasion for outside awards presented by other organizations, such as the American Bar Association. We restructured the Trial Judges Outreach Committee as a Subcommittee of the Membership Committee to assist with its focus on attracting more members from Tribal Courts. We restructured the Human Trafficking Committee as a subcommittee of the Immigration Project Committee, to coordinate the activities in furtherance of our grants on Immigration and Human Trafficking from the State Justice Institute.
- **e.** A special committee operating this year is the Strategic Planning Committee, chaired by Judge Brenda Loftin. The Strategic Planning Committee is updating NAWJ's strategic plan.

### 3. <u>Designation of NAWJ liaisons to Partner Organizations</u>

In addition to the Status Director positions on the NAWJ Board, elected per the NAWJ Bylaws for a Delegate to the ABA House of Delegates and Representative to the International Association of Women Judges, currently filled by Justices Fernande Duffly and Ann Walsh Bradley, respectively, we have appointed the following Liaisons or Representatives to other judicial, professional, and women's organizations with whom we share a common mission:

- Judge Ann Breen-Greco was appointed NAWJ Liaison with the ABA Human Trafficking Task Force. She holds a corresponding position with the ABA as NAWJ liaison on the Task Force.
- Judge Joy Lobrano was designated NAWJ Liaison to the <u>Advisory Committee</u> of the National Colloquium: Shelter and Services Evaluation for Action, which met in November 2012 in Washington DC.
- Judge Sue Yang was designated NAWJ liaison to the <u>National Consortium on Racial and Ethnic Fairness in the Courts</u>, which met March 20-23, 2013 in Washington DC. Our President-Elect Anna Blackburne-Rigsby chaired the 2013 meeting of the Consortium.
- Judge Kathryn Braeman was designated NAWJ liaison to the <u>American Association of University Women</u> and to the <u>National Women's History Museum</u>, both of which meet periodically.
- Judges Toni Clarke, Cheryl Cesario and Sophia Hall were designated as NAWJ representatives to the <u>ABA 2013 Summit on Perceptions of Justice</u>, in substitution for Judge Norma Shapiro, our original designee, who was unable to attend but who continued to serve on the Steering Committee. The summit met in Chicago on March 14 & 15, 2013. A report on the Summit, prepared by our member Judge Ann Breen-Greco, who also attended, is in the Appendix. NAWJ Member Judge William D. Missouri chairs the ABA Judicial Division which sponsored the Summit.
- The <u>National Judicial College</u> invited NAWJ to designate representatives to its series of three *50<sup>th</sup> Anniversary* Symposia which it is conducting this year. Judge Sheila Woods-Skipper was designated to represent NAWJ at the <u>NJC</u>

<u>50th Anniversary Symposium</u> in Philadelphia in April, Judge Lauretta Higgins Wolfson the Symposium in Chicago June 23-25, and Judge Eileen Burlison, the Symposium in Reno in September 9-11.

• Judge Arline Pacht was appointed NAWJ Liaison to the <u>National American</u> <u>Indian Court Judges Association.</u>

#### 4. Increased Use of Electronic Mail for dissemination of NAWI materials

To facilitate prompt delivery of our materials, to save on printing costs in some cases, to go "green," and to enable members to have electronic versions for their computers, we have disseminated copies of our materials electronically. A copy of the 2013 Directory was sent to all members electronically, while the hard copy was sent to the printer for printing and mailing. The electronic version reached our members a full 4 weeks before the hard copy arrived in our mailboxes. Our Meeting Binder, In lieu of being printed up and distributed at the Midyear Meeting, is being prepared for electronic distribution, so that it can be sent to Board Members in advance, so you have a chance to read and review it in advance of the meeting. Handouts for our Midyear Conference are being prepared on a Compact Disk for paperless distribution, and to give members an easy way to store them on their computers.

The State Chair concept has been institutionalized. For the first time, the names of State Chairs and their contact information are listed in the 2013 Directory. State Chairs are in place for 15 states, plus DC, Puerto Rico and the U.S. Virgin Islands.

Robert Kaufman, Esq., NAWJ Resource Board Member/Landmark Sponsor extraordinaire, has generously agreed to donate \$25,000 again this year and next to fund scholarships for international judges to attend the NAWJ annual conferences in 2013 and 2014. We have created a Conference Scholarship subCommittee of the International Outreach Committee, and appointed Hon. Judith Chirlin, Chair.

Our end of the year Holiday Appeal brought in just under \$12,000 from 55 Members.

#### Midyear Planning

The Midyear will be a truly exciting experience. Planning began over a year ago. We have combined our annual Joint Congressional luncheon for Women's Issues with our Midyear Board Meeting and Leadership Conference. We begin at noon on May 2 with the Caucus lunch in the Rayburn House Office Building of the House of Representatives. Interesting optional tours are offered for the afternoon. The Resource Board will meet in the afternoon, as will the Committee Chairs. A welcome reception is scheduled for 5:30pm at the law offices of Fulbright & Jaworski, LLP, where we shall be joined by the Shakespeare Theatre Company's Bard Association for a joint program on rights of women to confer benefits on men, inspired by the discussion of Salic law in Shakespeare's *Henry V*. Retired Social Security and military judges will bring the discussion forward to modern times reviewing Supreme Court decisions on social security and military benefits for male spouses. Late evening we shall gather at the hotel bar to mingle with new judges/new members/first time attendees.

The Midyear Board Meeting will take place Friday morning, May 3. District Directors will have an opportunity to meet separately over breakfast before the full Board meeting. Optional tours or free time will be available for members not attending the Board meeting. In the afternoon we go to the Supreme Court for a tour, followed by a panel discussion on recent immigration decisions by the Supreme Court, and then a Forum on independence issues for the special judiciary as compared with the general judiciary. We are expecting some of the members of the U.S. Supreme Court to join us at the reception there.

Saturday will be devoted to all day training on <u>Prevention of Human Trafficking – What Judges Can Do.</u> The morning speakers will provide a global overview of human trafficking as a growing form of organized crime, will share the perspective of the corporate community, and will include a mock examination of an expert witness. Our luncheon speaker will describe how trafficking cases overseas are making their way into U.S. courts. In the afternoon we shall have panels of practitioners and judges. We shall conclude with an interactive session reviewing bench cards and best practices.

The firm of McDermott Will generously hosted a kick off reception for the Midyear at their new space in December. We thank them and Lisa Horowitz, Esq., past president of the National Association of Women Lawyers for making the arrangements for that inspiring reception.

#### RESOLUTION

### **Urging Expeditious Filling of Federal Judicial Vacancies**

**WHEREAS** President Barack Obama is about to embark on his second term as President of the United States; and

**WHEREAS** one of a President's most important responsibilities is the selection and nomination of judges to all federal courts; and

**WHEREAS** it is the responsibility of the Senate to act on the nominations sent to it by the President; and

**WHEREAS** it is a mission of the National Association of Women Judges to promote a diverse judiciary; and

WHEREAS there are currently numerous vacancies on Federal courts; and

**WHEREAS** two-thirds of Americans now live in a state where there is a Federal judicial emergency, resulting in a major backlog of cases;

THEREFORE BE IT RESOLVED that the National Association of Women Judges urges President Obama to make it a priority for his administration to focus on Federal judicial selection and urges the Senate to work with the President to expeditiously fill the existing vacancies and fill future vacancies promptly as they arise.

NAWJ is the nation's leading voice for women jurists dedicated to preserving judicial independence and ensuring equal justice and access to the courts for women, minorities, and other historically disfavored groups. In accordance with this mission, NAWJ supports reauthorization of VAWA in a form that protects all victims of domestic violence and dating violence, including tribal victims living on reservations. Specifically, to improve the administration of justice, NAWJ supports the approach of the Senate version of the VAWA bill, which contains Section 904, a provision that would restore tribal jurisdiction over non-Indians for certain crimes of domestic violence and dating violence committed in Indian Country. It is important that VAWA protect all victims of domestic violence, including those tribal members who are victims of domestic violence committed in Indian Country.

# **Maryland House Bill 829**

Pregnant Detainees and Inmates – Restraint Restrictions and Reporting

The National Association of Women Judges (NAWJ) was founded in 1979 to, among other things, ensure equal justice for women, protect the rights of individuals, and bring about improvements concerning matters of importance in improving the administration of justice. NAWJ's diverse membership includes women and men at all levels of the federal, state, trial, military and administrative judiciary from nearly every state in the nation.

In furtherance of our mission to improve the administration of justice, NAWJ has long advocated for basic fairness and equity for people who are incarcerated. In 1991, NAWJ adopted a resolution urging an end to discrimination against incarcerated women. For years, NAWJ members in Maryland have volunteered in correctional facilities to bring educational programming to women and girls in prison.

In 2009, in recognition that leading medical and legal authorities have documented significant risk of harm in shackling pregnant women, and the lack of risk of flight that women pose in such circumstances, NAWJ members voted to adopt a resolution formally opposing the practice of shackling pregnant women and urging action by its members wherever such practices exist.

In furtherance of that commitment, NAWJ supports HB 829, and in particular, the proposed restrictions on the use of restraints on pregnant incarcerated girls and women in transportation, labor, and childbirth.

# REPORT ON ABA MID YEAR MEETING HUMAN TRAFFICKING PROGRAM

Sponsored by the National Conference of Specialized Court Judges and the National Conference of Administrative Law Judges co-sponsored by the National Association of Women Judges.

February 8, 2013 – Dallas Texas

#### Report prepared by Col. Linda Strite Murnane

On 8 February 2013, I had the opportunity to attend an excellent program on Human Trafficking, sponsored by the National Conference of Specialized Court Judges and the National Conference of Administrative Law Judges, and co-sponsored by the National Association of Women Judges. The program was presented during the American Bar Association's Mid-Year Meeting held in Dallas, Texas. I provide this report at the request of NAWJ President, the Honorable Joan Churchill.

American Bar Association President, Laurel Bellows, opened the program, discussing the important role lawyers and judges have in raising awareness of this form of modern day slavery. More than 60 people were in attendance at the program.

Speakers included: Norma Ramos from the Coalition Against Human Trafficking in Women, New York, NY; Shonnie Ball, from the Office to Monitor and Combat Trafficking, U.S. State Department; T. Markus Funk, Perkins and Coie, LLP, a former Federal Prosecutor and formerly with the State Department, and Mary Ellison, Director of Policy for the Polaris Project. The program was very capably moderated by The Honorable Pamila Brown, who is a member of the ABA National Conference of Specialized Court Judges and a member of the National Association of Women Judges.

Ms. Ramos noted the importance of debunking the myth that "women choose this" when they are forced to engage in prostitution as victims of human trafficking. She emphasized a need to follow the "Nordic Model" – attacking human trafficking by arresting and punishing the consumers rather than the victims of human trafficking. Ms. Ball encouraged a focus on the 3 "P"s – Prevention, Prosecution and Protection.

Mr. Funk currently advises companies on their obligations to comply with the law. He noted the focus on "transparency in the supply chain" of goods and services, ensuring that every level of goods and services are free of human trafficking. He discussed the September 25, 2012 Executive Order signed by President Obama, requiring that government contracts be awarded only to bidders that confirm their supply system is free of human trafficking. Notably, the Executive Order requires cooperation with law enforcement and requires affirmative reporting of instances of

trafficked labor. The rules for implementing the Executive Order are to be in place by March 2013.

Ms. Ellison discussed the operation of the National Human Trafficking Hotline, which has been in operation since December 2007 (888-373-7888). The hotline operates 24 hours a day, seven days per week and has handled more than 60,000 calls. Through the hotline, more than 9,000 victims of human trafficking have been identified. Ms. Ellison noted that the hotline is under the supervision of Health and Human Services, and that the Polaris Project operates the hotline under contract with HHS.

Additionally, Ms. Ellison noted that Polaris works on State and Federal trafficking policy. She noted that every State in the U.S. now has at least one human trafficking criminal offense included in its legislation, Wyoming having just passed their statute to achieve the 100% status in terms of statutory response to this problem. On the Polaris web site (<a href="http://www.polarisproject.org">http://www.polarisproject.org</a>), there is also legislation, information about service providers and resources to assist with helping victims of human trafficking arrayed by state.

Judge Brown noted the average age of trafficked persons is 13, and that more than 100,000 persons are at risk. Punishments for consumers of sexual services procured from human trafficking victims are minimal.

In addition to a CD with extensive information and resources, the program participants were also provided with the U.S. Department of State's "Trafficking in Persons Report", June 2012. ## REPORT OF ABA SUMMIT ON PERCEPTIONS OF JUSTICE March 14 – 15, 2013 Chicago, IL

The ABA hosted the Judicial Division's Perceptions of Justice Program in Chicago on March 14 and 15, 2013. A number of NAWJ members attended including Judges Cheryl Cesario, Sophia Hall, Toni Clark, and Ann Breen-Greco. The ABA JD ensured that attendees included physically challenged individuals and LGBT representatives. In addition to representatives of NAWJ and all the ABA JD Conferences and ABA Commissions and Standing Committees, attendees included the American Association for Justice, American Judicature Society, Brennan Center for Justice at NYU School of Law, Coalition on Racial and Ethnic Justice (CORE), Federal Magistrate Judges Association, International Association of LGBT, Justice at Stake, Kettering Foundation, National Association for Court Management, National Association of State Judicial Educators, National Bar Association, National Center for State Courts, National LGBT Bar Association, National Native American Bar Association, and Williams Institute.

According to the Program materials, the Program has been developing since the late 1980s when many federal and state courts studied how litigants, jurors, attorneys, judges, and the general public perceived the administration of justice. In particular, the courts were concerned with how litigants' race or ethnicity affected the actual administration of justice, and the public's perception of how the courts responded to race and ethnicity. These studies led to reports and recommendations and several states created "listening" programs for members of the public to share their experiences with the justice system.

In 2008, the ABA Judicial Division Lawyers Conference created the Perceptions of Justice project. The Lawyers Conference held programs nationwide in Boston, Dallas, Chicago, Washington, D.C., San Francisco, and Atlanta. Each event was uniquely designed to provide education and a forum for open dialogue between judges and members of the community about perceptions of and personal experiences with the justice system. A modified "town hall" format with small group discussions was used for some programs and expert panels with audience participation were employed in others.

The Chicago Summit promoted opportunity for in-depth discussion on all forms of bias in the courts, which generated ideas on how to address these issues, including future training for all components of the legal profession. ABA JD will issue a report on findings and recommendations.

#### APPENDIX II B 3

Summary of Meeting of the ABA International Courts and Rule of Law Committee

Saturday, 9 February 2013 Dallas, TX

During the Mid-Year Meeting of the American Bar Association, the International Courts and Rule of Law Committee met at 2 p.m. on Saturday, 9 February 2013. This is a brief report highlighting the matters discussed by members of the committee who were able to attend.

Committee members in attendance: Judge Mary Margaret Anderson, Judge Ed Felter, Judge Ruth Kleinfeld, Colonel Linda Strite Murnane. Visitor: Mr. Cody Blake Leger.

Judge Mary Margaret Anderson gave an update on the ICC Judicial Exchange Project which is being led by the ABA International Human Rights Committee. Judge Anderson briefed committee members on the report she received from ABA Staff Attorney, Kip Hale, which included updates on a visit to the International Criminal Court by Mr. Hale, ABA Past President Michael Greco, Judge Andre Davis, and National Judicial College President Bill Dressel. Judge Anderson advised that she has continued to inform Mr. Hale that the Judicial Division stands ready to assist. It seems, however, that the ICC is actually interested in a very specific team of judges, including judges with international tribunal experience such as Judge Patricia Wald and Judge Gabrielle Kirk McDonald. The current status appears to be that Mr. Hale has organized a proposal that was presented to the ICC, and the project is currently being presented to possible sources to fund the program. Judge Anderson asked the International Courts and Rule of Law Committee to include the monitoring of this project as part of its ongoing activities, and she indicated she was happy to continue to serve as the focal point for the discussions with the ABA International Human Rights Committee.

Chair of the Committee, Ms. Murnane, informed the committee members of the upcoming trip to Paris, France and The Hague, The Netherlands, being planned by the National Bar Association's Judicial Council. The dates of the international trip are 28 May to 5 June, 2013. Point of contact for information is Judge Marguerite Downing, LA Superior Court (MDowning@LASuperiorCourt.org)

Members in attendance were asked if they wanted to continue to receive the UN Development Program opportunities, the American Society of International Law updates, as well as Tribunal and International Court updates. The members in attendance agreed that this information was helpful and of interest.

# REPORT OF PRESIDENTIAL SIGNING CEREMONY OF VAWA REAUTHORIZATION Thursday, March 7, 2013

Executive Director Marie Komisar and I had an exciting time today participating in the celebration of the signing of S4, the Violence Against Women Reauthorization Act. We joined representatives of many women's organizations, as well as Tribal and LGBT who were there to celebrate. There were so many groups interested, that the signing had to be moved from the usual White House location to the Interior Department auditorium, to accommodate everyone.

The celebration began with a moving testimony by a Tribal woman who explained that heretofore, no law enforcement agency had jurisdiction over abuse she suffered at the hands of her non-Indian husband on Indian lands where they lived. Vice President Biden, who crafted the original VAWA 20 years ago with Congressman Conyers, spoke of how with each reauthorization, provisions are added to strengthen the Act. He and President Obama hailed the provisions of S47 which enlarge the scope of the Act to include coverage of Native Americans and members of the LGBT community. Others on the stage included Congressman Conyers, Sen. Patrick Leahy, Chair of the Judiciary Committee, who championed the bill, Sen. Susan Collins, Minority Leader Nancy Pelosi, and Minority Whip Steny Hoyer.

NAWJ has been a supporter of VAWA since it was first enacted. Our Executive Committee issued a Statement of Support in December 2012, for the Senate bill pending in the past Congress, and again March 1, 2013 in support of S47. We want to thank our members Dana Fabe, Arline Pacht, co-Chairs of the NAWJ Tribal Outreach subcommittee, Ellen Siwak and Michelle Christianson, co-Chairs of the NAWJ Domestic Violence Committee, and the New York Chapter headed by Justice Darcel Clark, President, as well as members Judges Katherine Hansen and Judges Marcy Clark, for their help with the Position Statement. # Human Trafficking and the State Courts Collaborative Overview

Spring 2013

Establishing an appropriate state court role in addressing the numerous and complicated forms of modern human trafficking is one of the most difficult challenges likely to confront state courts and their justice partners in the coming decade. While human trafficking is widespread and growing across the nation, what state courts can do to adjudicate cases involving trafficking victims and traffickers remains elusive. As one response, early in 2013, the State Justice Institute provided funding to establish a Human Trafficking and the State Courts Collaborative initially composed of the Center for Public Policy Studies (CPPS), the Center for Court Innovation (CCI), and the National Judicial College (NJC). The work of the Collaborative will focus on four strategic priorities:

- increasing understanding and awareness about the challenges faced by state courts in dealing with cases involving trafficking victims and their families, and traffickers:
- developing and testing state and local approaches for assessing and addressing the affects on the state courts of adjudicating cases involving human trafficking victims and defendants;
- enhancing state and local court capacity to improve court services in cases involving human trafficking; and
- building effective national, state, and local partnerships for addressing human trafficking case processing in the state courts.

The Human Trafficking and the State Courts Collaborative has undertaken the following activities to address the challenges and four strategic priorities:

- identifying the major challenges and opportunities state courts need to address when dealing with trafficking victims and traffickers;
- establishing a web-based resource network and clearinghouse;
- preparing bench cards, best-practice guidelines, tool-kits, and other resources to help court practitioners and their justice partners address human trafficking
- developing and testing replicable approaches to providing technical assistance in six diverse court jurisdictions for addressing the challenges courts face in cases involving human trafficking;
